





# SHARING ON FOUNDERS WRITINGS

- Sharing sessions happened Before (Virtually) and during the conference. For a total of 3 Hours.
- No Areas in favor of changing the founder's writings.
- Members were in favor of new literature to meet needs of newcomers.
- A Number areas felt there should be a policy on changes to the founder's writings, e.g., 2 Year Process and/or a 3/4 super majority to pass a change.

# GENERAL SERVICE BOARD REPORT

2023 Advisory Action: General Service Board is asked to undertake an inventory prior to the 74th General Service Conference.

#### 1. Communication and Unity:

- Goal: Develop a unified communication strategy to ensure consistent messaging.
- Establish **clear communication protocols** and **define terms** to ensure consistent understanding among board members.
- Foster an environment of trust and inclusivity among board members to encourage open communication and unity.
- Encourage engagement with the Fellowship and regional events to strengthen connections and communication channels.

#### 2. Leadership Development:

- Goal: Provide effective leadership development focusing on spiritual principles and effective communication.
- Conduct leadership training sessions away from board weekends to facilitate strategic planning and board development.
- Address toxic relationships and inappropriate behavior through leadership training and the **development of clear policies**.

#### 3. Support and Engagement:

- Goal: Provide support for staff, delegates, and board members to foster a healthy and inclusive environment.
- Establish **cross-functional group of conference members** to identify problems and solutions, promoting collaboration and inclusivity.
- Prioritize workload effectively and create a healthier environment through schedule management and support mechanisms.
- Implement a **zero-tolerance policy for mistreatment** and ensure timely communication and support for all stakeholders involved.

## REPORT FROM AAWS

- There have been 8 AAWS Board meetings and 3 strategic planning sessions since the 2023 General Service Conference, as well as over 30 virtual interim meetings of AAWS committees, ad hoc committees, and subcommittees, all to carry out the work with which the board is entrusted.
- The Staff Services Department:
  - Responded to 165,420 emails and 1,677 phone calls, an average of 15,000 emails and roughly 1,250 work hours per staff member.
  - Welcomed 1,470 visitors and 12 large groups of more than 20 members to GSO in 2023, with ten groups booked through June of this year.
- In the past year, the Language Services Department received over 1,500 translation requests, not including Conference background materials.
- The GSO Archives Department consisting of roughly 2,642 cubic feet of holdings, responded to 1,450 research requests and welcomed five onsite researchers.

## RELOCATION STUDIES OF THE GENERAL SERVICE OFFICE

Chair: Carolyn W. (General Service Trustee)

Hire firm specializing in corporate relocations Cost: \$177K

#### Scenarios:

- 1. Base Case (Stay and Renew Lease at 475 Riverside Drive)
- 2A. Downtown New York
- 2B. Jersey City, New Jersey (to minimize commute)
- 3. Long distance Locations (3 finalists: Atlanta, Indianapolis, and Philadelphia)
  - 116 qualified metro areas across the U.S

#### Criteria

- Office lease rates
- Accessibility to public transportation
- Commute impact
- Quality of life ranking
- Cost of living expenses (housing and personal taxation)

- Operating expenses
- Wages
- Professional talent
- Moving costs
- Proximity to air transportation

**PLUS:** in-depth review of internal operations and needs to inform location selection

#### **Conclusions:**

- The case to move does not support up front costs as high as \$7.1 million, and likely very high attrition of staff (>80%), in turn impacting the ability to support GSO's service mission to Members.
- Scenarios 2A and 2B: <u>A local move has no financial or operational advantage</u>.
- Scenario 3: Initial upfront costs to move (relocation and capital) are significant (between \$6.6 and \$7.1 million). Highly disruptive, predicted to exceed 80% move-induced attrition rate in personnel

## 2023 GSO FINANCIAL HIGHLIGHTS

- 7<sup>th</sup> Tradition of Self-Support \$10.84 million up 2.8% from \$10.55 million in 2022
- Operating Expense before Depreciation \$17.47 million up 9.9% from \$15.90 million in 2022
  - Program Service Expense \$9.00 million up 46.5% from \$6.14 million in 2022
  - Supporting Services Expense \$8.47 million down 13.1% from \$9.76 million in 2022
- Self-Support covered 62% of operating expense
- Cost of program services per individual \$6.43
- AAWS publishing gross profits \$6.76 million up 38.2% from \$4.89 million in 2022
- Operating surplus before depreciation of \$581,907; operating cash increase of \$358,588



## 2023 GRAPEVINE FINANCIAL HIGHLIGHTS


- App launch September 1, 2023
- Grapevine paid print subscription income decreased 12% in 2023. Subscription income for the online, complete and mobile app magazine increased 72% due to the mobile app and increased Complete subscriptions.
- 2023 Grapevine results were a gross margin on subscriptions of \$601,088 and a gross margin of \$562,746 on other published items. Operating expenses of \$2,059,058 resulted in an operating loss of \$888,465 compared to a loss of \$404,940 in 2022.
- General Fund support of La Viña service activity was \$753,376 in 2023, compared to \$636,604 in 2022.
- La Viña magazine circulation decreased by 3.0% in 2023 compared to a 4.3% increase in 2022.


## **2024 GSO BUDGET**

- Operating revenue \$19,642,359 compared to \$18,056,782 in 2023.
  - Contributions \$10,500,000 compared to \$10,841,419 in 2023.
  - Literature gross margin \$8,492,759 compared to \$6,763,226 in 2023.
- Total operating expense \$19,024,414 before \$1.02M depreciation compared to \$17,474,874 before \$1.06M depreciation in 2023.
- Operating surplus of \$617,945 before depreciation compared to \$581,907 surplus in 2023.

## **2024 GRAPEVINE BUDGET**

- Print magazine circulation expected to decrease to 46,969 from 49,296 in 2023.
- Online and Complete circulation to increase to 4,625 from 3,002 in 2023.
- ◆ 10,069 new app subscribers compared to 3,400 in 2023.
- Gross margin on subscriptions \$1,147,021 compared to \$601,088 in 2023.
- Grapevine net deficit of \$582,572 compared to a net deficit of \$888,465 in 2023.
- La Viña magazine circulation to increase to 6,782 compared to 6,484 in 2023.
- General Fund La Viña support of \$569,512 compared to \$753,376 in 2023.

#### FINANCE

#### **Approved**

• The maximum annual contribution from an individual A.A. member to the General Service Board be increased from \$5,000 to \$7,500.

#### **Committee Consideration**

Review progress report reflecting <u>shared experience</u> from the Fellowship on possible future changes to literature written by <u>A.A.'s founders</u>.

The committee reviewed the progress report reflecting shared experience from the Fellowship on possible future changes to literature written by A.A.'s founders and took no action. After thorough consideration and mindful reflection of the comments received from Founders' Writings sharing sessions, as well as the valuable input received from the Fellowship via Area Delegates, the committee agreed that current Conference procedures provide a process wherein future proposals for changes can be considered by the group conscience of <a href="mailto:each">each</a>
Conference, negating the need for a mandated policy.

## GRAPEVINE / LA VIÑA

#### **Approved**

 The AA Grapevine Board develop a 5-year financial plan for La Viña with the goal to reduce shortfalls and increase revenue to be brought back to the 2025 Conference Committee on Grapevine and La Viña.

#### Committee Consideration:

 The committee requested that the Grapevine Board develop a Grapevine and La Viña financial reporting system that is clearer and easier to understand for the Fellowship.

The committee considered a request to develop a pamphlet on the <u>Asian and Asian-American</u> alcoholic in A.A. and <u>took no action</u>.

#### **Approved**

- The committee recommended that the draft of the revised pamphlet "A.A. for the Black and African American Alcoholic" (retitled "Black in A.A.: Experience, Strength and Hope") be approved with the following minor editorial changes:
  - Generalize terminology surrounding drug and addiction references.
  - Removal of one story.
  - The removal of the political commentary within two stories.

#### **Approved**

- The committee recommended that the draft manuscript Plain Language Big Book: A Tool for Reading Alcoholics Anonymous be approved with minor editorial changes to include:
  - Relocation of the "A.A. Steps Table" to constitute an Appendix (on the Twelve Steps) at the back of the new publication.
  - Replace the references to "addiction" and "addicted" with language related to alcoholism.

#### Plain Language Big Book: A Tool for Reading Alcoholics Anonymous

#### **2021 Conference Advisory Action**

It was recommended that a draft version of the book, Alcoholics Anonymous (Fourth Edition), be translated into plain and simple language and be developed in a way that is **accessible** and **relatable** to as **wide** of an audience as possible.

#### 2024 Conference Committee on Literature

- Committee spent 10 Hours Saturday reading and reviewing chapter by chapter.
- Committee recommended moving the table containing original 12 step text and an explanation of each step to an appendix.
- Committee recommended replacing text referring to alcoholism as an addiction.

#### **Approved**

  - Age of pamphlets
  - Declining demand
  - Emphasis through other projects to create online material for young people
  - As an action on reviewing the Recovery Literature Matrix

#### **Approved**

- The committee recommended permanently suspending the "Too Young?" video adaptation project.
  - Cost High probability of going over \$100K (No expenditures to date)
  - Other projects in the works and further along

#### **Committee Consideration:**

- The committee reviewed a progress report on the development of the Fifth Edition of the book Alcoholics Anonymous. The committee looks forward to a progress report or draft manuscript to be brought back to the 2025 Conference Committee on Literature.
  - All stories through first review (160 stories selected for next review)
- The committee reviewed a progress report on the development of the Fourth Edition of the book Alcohólicos Anónimos Spanish. The committee noted that the story submissions reflect a broad and diverse cross-section of the A.A. Fellowship, reflecting each of A.A.'s Three Legacies. The committee requested that a draft manuscript or progress report be brought back to the 2025 Conference Committee on Literature.
  - Continued work on Story review.
  - Translation work in-progress

## POLICY/ADMISSIONS

#### **Approved**

- The <u>Equitable Distribution of Workload</u> (EDW) process be adopted and implemented.
- The Proposed Agenda Item (PAI) submission date deadline for the 2025 General Service
   Conference be moved to a date no earlier than September 30, 2024
  - To accommodate the staff preparing Background and for the PAI's to be reviewed.

#### **Committee Considerations:**

Participation of Online Groups in the U.S./Canada Service Structure

Based upon the Ad Hoc report findings, the committee noted that at this time there are no clearly expressed needs for the creation of an additional Delegate area for online groups, at this time. The committee noted a guideline service piece on the participation of online groups may be a helpful resource.
